Why access and inclusion matters

- Disabled people constitute the largest minority group
- 12-15% = >1 billion disabled people worldwide (WHO stats)
 - 1% wheelchair users
 - 2% learning/intellectually disabled people
 - 15% Deaf or hard or hearing people
 - 3.5% partially sighted and blind people
- 1 in 4 people will experience mental ill-health
- Disabled people may have more than one 'disability'
- >50% of disabled people have never attended a public or sporting event





Why access and inclusion matters

- Disabled people are excluded by societal barriers
 - Physical, sensory, intellectual and attitudinal
 - Most common being attitudinal barriers & stereotyping
- Disabled people influence choice family & friends
 - Provide new business opportunities
 - > Fan base & increased revenue
- >20% of any population will require good access at given time
 - Young and older fans
 - People who speak different languages
- Accessible facilities and services benefit all of us





Why access and inclusion matters

- Accessible stadiums are;
 - Customer focused and welcoming
 - Provide an inclusive fan experience for all
 - More sustainable & more financially viable
 - A legal requirement in many countries
- Inclusive clubs and accessible stadia enhance reputation
 - Appreciated by many stakeholders
 - Including customers, clients, fans and sponsors

Good Practice Guide to Creating an Accessible Stadium and Matchday Experience – October 2011

- Available in 14 languages, including Croatian
- Sets out minimum European standards
- Practical solutions and guidance
- New and existing stadia

New UEFA Financial Fairplay & Club Licensing criterion Introduced 1 July 2015

- Disability Access Officers
- Local club based experts/advisors







UEFA Club Licensing criterion - 35bis Disability access officer (DAO)

The licence applicant must have appointed a disability access officer to support the provision of inclusive, accessible facilities and services.

The disability access officer will regularly meet and collaborate with the relevant club personnel on all related matters.





Disability Access Officer (DAO) Implementation

- CAFE commissioned by UEFA
 - To support National Associations
- National Associations to;
 - Include criterion in club licensing rules
 - Provide advice & support to their clubs
 - Collate DAO and club access information
- CAFE to support DAO training workshops across Europe
- CAFE to share best practices and to collate access policies



Disability Access Officer (DAO) Benefits

- Local club based dedicated Disability Access Officers
- May be employed, part-time or volunteer
- Working towards best practice accessible stadia standards
- Supporting & advising club departments & operations
 - Disabled fans and guests (ticketing, accommodation & services)
 - Dedicated contact point for disabled fans
 - Positive dialogue between disabled fans and club
 - Disabled employees and volunteers
- Providing expert disability and access advice and training across club



Disability Access Officer (DAO) Key skills & experience

- Access & inclusion expert or basic knowledge & willingness to learn
- Good understanding of:
 - UEFA & CAFE Access for All guide and minimum standards
 - Local disability legislation & building regulations
 - Pan-disability understanding of accessible services
- Commitment to seeking & sharing best practice solutions
- Knowledge of local disability NGOs & their resources
- Able to inspire, motivate & to train & support colleagues
- Able to promote & champion the needs of disabled people across the club!



Disability Access Officer Responsibilities - access

- Assist club in fulfilling its access requirements
 - Planning inclusion year-on-year
 - New stadia developments
 - Improving existing facilities
 - Accessible services
- Providing accessible information
 - Getting to the stadium
 - Matchday facilities & services
 - Non-matchday (shop, museum, etc.)
- Employing disabled people





Disability Access Officer (DAO) Responsibilities – inclusion

- Advice & support club & personnel including the board
 - Participation access advice to disability football coaches
 - Matchdays Disabled spectators, guests and VIPs
 - Encourage disabled people to attend matches (new fans)
- Provide disability awareness training to all staff
- Review access policies, facilities and services
- Forge relationships with local disability NGOs







Disability Access Officer (DAO) Summary

- New UEFA FFP & CL criterion
- UK and Germany most established
- Organic process across Europe with CAFE support
- Employed by and responsible to the club
- Support and advise club on access & inclusion
- DAOs may be paid, part-time or volunteers
- Champion change & access developments within club
- Not the same as the SLO role
- Create Access & Inclusion for All with many more disabled people!
